You must declare that you meet at least one of the listed qualification(s) and should cross through any that do not apply . Those left should match the qualification(s) as given on your home address form.	

¹ This is not to be used for mayoral or principal area elections. Separate <u>forms and guidance are available</u>.

You must not sign the form if you are disqualified to stand. Make sure that you read the Electoral Commission guidance on standing for election as well as the legislation listed. If you are not sure if you are able to stand you should contact your employer (where relevant), consult the legislation or, if necessary, take your own independent legal advice.

Notes

- The attention of candidates and electors is drawn to the rules for filling up nomination papers and other provisions relating to nomination papers contained in the election rules in the Local Elections (Parishes and Communities) Rules 2006 (as amended).
- **2.** Where a candidate is commonly known by some title they may be described by their title as if it were their surname.
- **3.** Where a candidate commonly uses a name that is different from any other name they have, the commonly used name may also appear on the nomination paper, but if it does so, the commonly used name (instead of any other name) will appear on the ballot paper.
- **4.** But the ballot paper will show the other name if the returning officer thinks that the use of the commonly used name may
 - (a) be likely to mislead or confuse electors, or
 - (b) that the commonly used name is obscene or offensive.
- 5. An elector may not -
 - (a) subscribe more nomination papers than there are vacancies to be filled in the electoral area in which the election is held; or
 - (b) subscribe a nomination paper for more than one ward in a parish divided into wards.
- 6. In this form 'elector' -
 - (a) means a person whose name is registered in the register of local government electors for the electoral area in question on the last day for the publication of notice of election; and
 - (b) includes a person then shown in the register as below voting age if (but only if) it appears from the register that he will be of voting age on the day fixed for the poll.
- **7.** However, a person who has an anonymous entry in the register of local government electors cannot nominate a candidate for election.

Local Government Act 1972

80. Disqualifications for election and holding office as member of local authority.

- (1) Subject to the provisions of section 81 below, a person shall be disqualified for being elected or being a member of a local authority if he
 - (a) holds any paid office or employment (other than the office of chairman, vice-chairman, deputy chairman, presiding member or deputy presiding member or, in the case of a local authority which are operating executive arrangements which involve a leader and cabinet executive, the office of executive leader or member of the executive) appointments or elections to which are or may be made or confirmed by the local authority or any committee or sub-committee of the authority or by a joint committee or National Park authority on which the authority are represented or by any person holding any such office or employment; or
 - (b) is the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order, or a debt relief restrictions order under Schedule 4ZB of the Insolvency Act 1986; or
 - (c) [This has been removed and no longer applies]
 - (d) has within five years before the day of election or since his election been convicted in the United Kingdom, the Channel Islands or the Isle of Man of any offence and has had passed on him a sentence of imprisonment (whether suspended or not) for a period of not less than three months without the option of a fine; or
 - (e) is disqualified for being elected or for being a member of that authority under Part III of the Representation of the People Act 1983.
- (2) Subject to the provisions of section 81 below, a paid officer of a local authority who is employed under the direction of
 - (a) a committee or sub-committee of the authority any member of which is appointed on the nomination of some other local authority; or
 - (b) a joint board, joint authority, economic prosperity board, combined authority, joint waste authority or joint committee on which the authority are represented and any member of which is so appointed;

shall be disqualified for being elected or being a member of that other local authority.

- (2AA) A paid member of staff of the Greater London Authority who is employed under the direction of a joint committee the membership of which includes
 - (a) one or more persons appointed on the nomination of the Authority acting by the Mayor, and
 - (b) one or more members of one or more London borough councils appointed to the committee on the nomination of those councils,

shall be disqualified for being elected or being a member of any of those London borough councils.

(2A) Subsection (2) above shall have effect as if the reference to a joint board included a reference to a National Park authority

Parish election in England

- (2B) For the purposes of this section a local authority shall be treated as represented on a National Park authority if it is entitled to make any appointment of a local authority member of the National Park authority.
- (3) Subsection (1)(a) shall have effect in relation to a teacher in a school maintained by the local authority who does not hold an employment falling within that provision as it has effect in relation to a teacher in such a school who holds such an employment.
- (5) For the purposes of subsection (1)(d) above, the ordinary date on which the period allowed for making an appeal or application with respect to the conviction expires or, if such an appeal or application is made, the date on which the appeal or application is finally disposed of or abandoned or fails by reason of the non-prosecution thereof shall be deemed to be the date of the conviction.

81 Exception to provisions of section 80

- (4) Section 80(2) and (3) above shall not operate so to disqualify -
 - (a) any person by reason of his being a teacher, or otherwise employed, in a school or other educational institution maintained or assisted by a county council for being a member of a district council by reason that the district council nominates members of the education committee of the county council

81A Disqualification relating to sexual offences etc

- (1) A person is disqualified for being elected or being a member of a local authority in England if the person is subject to—
- (a) any relevant notification requirements, or
- (b) a relevant order.
- (2) In this section "relevant notification requirements" means—
- (a) the notification requirements of Part 2 of the Sexual Offences Act 2003;
- (b) the notification requirements of Part 2 of the Sex Offenders (Jersey) Law 2010;
- (c) the notification requirements of Part 2 of the Criminal Justice (Sex Offenders and Miscellaneous Provisions) (Bailiwick of Guernsey) Law 2013;
- (d) the notification requirements of Schedule 1 to the Criminal Justice Act 2001 (an Act of Tynwald: c. 4).
- (3) In this section "relevant order" means—
- (a) a sexual harm prevention order under section 345 of the Sentencing Code;
- (b) a sexual harm prevention order under section 103A of the Sexual Offences Act 2003:
- (c) a sexual offences prevention order under section 104 of that Act;
- (d) a sexual risk order under section 122A of that Act;
- (e) a risk of sexual harm order under section 123 of that Act:

- (f) a risk of sexual harm order under section 2 of the Protection of Children and Prevention of Sexual Offences (Scotland) Act 2005;
 - (g) a sexual risk order under section 27 of the Abusive Behaviour and Sexual Harm (Scotland) Act 2016;
 - (h) a restraining order under Article 10 of the Sex Offenders (Jersey) Law 2010;
 - (i) a child protection order under Article 11 of that Law;
 - (j) a sexual offences prevention order under section 18 of the Criminal Justice (Sex Offenders and Miscellaneous Provisions) (Bailiwick of Guernsey) Law 2013;
 - (k) a risk of sexual harm order under section 22 of that Law;
 - (I) a sexual offences prevention order under section 1 of the Sex Offenders Act 2006 (an Act of Tynwald: c. 20);
 - (m) a risk of sexual harm order under section 5 of that Act.
 - (4) For the purposes of subsection (1)(a), a person who is subject to any relevant notification requirements is not to be regarded as disqualified until—
 - (a) the expiry of the ordinary period allowed for making an appeal or application against the conviction, finding, caution, order or certification in respect of which the person is subject to the relevant notification requirements, or
 - (b) if such an appeal or application is made, the date on which it is finally disposed of or abandoned or fails because it is not prosecuted.
 - (5) For the purposes of subsection (1)(b), a person who is subject to a relevant order is not to be regarded as disqualified until—
 - (a) the expiry of the ordinary period allowed for making an appeal against the relevant order, or
 - (b) if such an appeal is made, the date on which it is finally disposed of or abandoned or fails because it is not prosecuted.

Localism Act 2011

Section 34(4) describes how a person may be disqualified from standing in local government elections under this section. The remaining provisions of section 34 do not directly affect a person's entitlement to stand for election

34 Offences

- (1) A person commits an offence if, without reasonable excuse, the person—
 - (a) fails to comply with an obligation imposed on the person by section 30(1) or 31(2), (3) or (7),
 - (b) participates in any discussion or vote in contravention of section 31(4), or
 - (c) takes any steps in contravention of section 31(8).
- (2) A person commits an offence if under section 30(1) or 31(2), (3) or (7) the person provides information that is false or misleading and the person—

- (a) knows that the information is false or misleading, or
- (b) is reckless as to whether the information is true and not misleading.
- (3) A person who is guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 on the standard scale.
- (4) A court dealing with a person for an offence under this section may (in addition to any other power exercisable in the person's case) by order disqualify the person, for a period not exceeding five years, for being or becoming (by election or otherwise) a member or co-opted member of the relevant authority in question or any other relevant authority.
- (5) A prosecution for an offence under this section is not to be instituted except by or on behalf of the Director of Public Prosecutions.
- (6) Proceedings for an offence under this section may be brought within a period of 12 months beginning with the date on which evidence sufficient in the opinion of the prosecutor to warrant the proceedings came to the prosecutor's knowledge.
- (7) But no such proceedings may be brought more than three years—
 - (a) after the commission of the offence, or
 - (b) in the case of a continuous contravention, after the last date on which the offence was committed.
- (8) A certificate signed by the prosecutor and stating the date on which such evidence came to the prosecutor's knowledge is conclusive evidence of that fact; and a certificate to that effect and purporting to be so signed is to be treated as being so signed unless the contrary is proved.
- (9) The Local Government Act 1972 is amended as follows.
- (10) In section 86(1)(b) (authority to declare vacancy where member becomes disqualified otherwise than in certain cases) after " 2000 " insert " or section 34 of the Localism Act 2011".
- (11) In section 87(1)(ee) (date of casual vacancies)—
 - (a) after "2000" insert " or section 34 of the Localism Act 2011 or ", and
 - (b) after "decision" insert " or order ".
- (12) The Greater London Authority Act 1999 is amended as follows.
- (13) In each of sections 7(b) and 14(b) (Authority to declare vacancy where Assembly member or Mayor becomes disqualified otherwise than in certain cases) after sub-paragraph (i) insert—
 - "(ia) under section 34 of the Localism Act 2011,".
- (14) In section 9(1)(f) (date of casual vacancies)—
 - (a) before "or by virtue of" insert "or section 34 of the Localism Act 2011", and
 - (b) after "that Act" insert " of 1998 or that section ".

Voter Authority Certificates (Voter ID)

As you are hopefully aware, all electors who vote at a polling station will need to provide an acceptable form of photographic identification. If they do not have an acceptable ID a **FREE** voter authority certificate can be provided. Further details regarding this can be found on our website. We would encourage you to inform anyone you meet as part of your campaign.

Notices

Please note regarding the use of the word Agent below, Agents are only appointable by District Candidates.

Statement of Person's Nominated will be available on the Website. (Copies are not being sent out to each Candidate/Agent.

Notice of Election Agents will be available on the Website.

Notice of Time & Place for Opening of Postal Votes will either be emailed to Candidates and Agent's or sent in the post (only if email address is not supplied).

Notice of Poll/Situation of Polling Stations will either be emailed to Candidates and Agent's or sent in the post (only if email address is not supplied).

Appointment of Postal Vote Agents & Counting Agents will either be emailed to the Candidate or sent in the post (only if email address is not supplied).

These forms will not be sent to the Agent.

Candidates Expenses Forms for Completion with be emailed to the Candidate or sent in the Post. These forms will not be sent to the Agent. (Two sets will be sent if Candidate is standing for both District & Parish.

Secrecy Notice. This will be sent to Candidate & Agents either by email or post (only if email address is not supplied).

Important Dates

17th **March** – Nomination Packs available from The Elections Office located at Lynton House, Commercial Road, Barnstaple. EX31 1DG by phoning 01217 388277, or via the Council's website.

17th March - Registers of Electors and Postal Vote lists for candidates will be available on request. A form is required to be completed which will be included in the nomination pack. The Registers/Postal Vote lists can be provided in paper copies (MUST BE COLLECTED IN PERSON AT LYNTON HOUSE by prior arrangement) or Data Format which can be emailed but it will be password protected so you must ensure you can open it. Ensure you have 7zip installed on your computer.

You will need to contact the Elections Office for the password once you have received the encrypted data.

If you haven't got this software you can download as follows:-

- Download 7zip Encryption Software from www.7-zip.org/download.html and choose the top link. This is free and simple to download.
- Once you have clicked on this link, it will come up with a box at the bottom of your computer screen called something similar to "7z0000.exe." Open this and install with all defaults. Once finished, you will need to restart your computer.

Please contact the Elections Office if you need an Instructions guide.

27th **March**– Poll Cards will hit doorsteps and will refer to all Elections taking place in that area.

4th April – Close of nominations and withdrawals & Appointment of Election Agents at 4pm. Nominations MUST be delivered by hand, nominations sent through the post will not be accepted and will be classed as undelivered. Delivery times are 09.30am-4pm weekdays.

17th **April** – Last day for receipt of applications to register to vote

18th April – Last day for receipt of new and changes to postal and postal proxy applications (5pm)

20th **April** – Issue of postal votes, all sent 1st class

24th **April** – Postal vote openings begin, 10am onwards at Brynsworthy Offices. This day will be classed as a Test Day to ensure equipment is working correctly and it maybe that a limited number of postal votes will be opened. Please note, the ballot papers are dealt with face down and any attempt to see a vote by an observer may result in the removal of that person.

Verification is where we check the number of papers issued corresponds with the number of papers in each ballot box. Following this the District will be counted which will continue into the early hours of 5th May.

5th **May** – 10am Onwards. All Parish Election papers will be counted at the Tarka Tennis Centre.

Nominations

<u>Agents</u>

Please note, agents are not applicable for Parish Candidates.

Home address form

Candidates will have the option of not having their address published on Notices and Ballot Papers.

However please note if you do not appoint an Agent, you will be deemed as your own agent and your address will be published on the Notice of Election Agents.

Mobile numbers/Email addresses

Please ensure you provide your mobile number/Email address. Wherever possible we will be sending information by email. If elected, we will also pass on your contact details to Member Services/Parish Clerks so they may contact you.

Political Parties

If you are intending on standing on behalf of a registered party you will need a certificate authorising you to use the party name or a registered description on the ballot paper (known as the certificate of authorisation). Also a written request to use one of the party's emblems (if you would like one to appear on the ballot paper).

District Candidates only

If you are not standing for a political party then your description on the nomination paper must be either 'Independent' or left blank.

Parish Candidates only

If you are not standing for a political party then your description on the nomination paper must not exceed 6 words.

Proposers and Seconders

Please note the legislation has changed and District nominations no longer require assenters.

A person may sign as many nomination papers as there are seats for that election. For instance, District is a mix of single, double and triple seats so depends on the area. For Parish the limit is the total number of seats available for that Parish.

All nominations papers are required to be delivered **by hand** to Lynton House, Commercial Road, Barnstaple, EX31 1DG, between the hours of 09.30am to 4pm (Monday to Friday) **If** the reception is closed we can be contacted via the intercom on the riverside entrance to Lynton House.

Any nominations sent through the post cannot be accepted and will be classed as undelivered.

Return of Election Expenses

- + 35 days from declaration of result District Election Expenses are required to be submitted to the Elections Office at North Devon District Council, Lynton House. (9th June 2023).
- + 28 days from declaration of result Parish Election Expenses are required to be submitted to the Elections Office at North Devon District Council, Lynton House. (2nd June 2023)

Candidates Election Expenses

There is a maximum that candidates can spend on their campaign and this will be available on the Council's website from 27th March 2023.

(District & Parish £806 plus 7p per elector). Please note that expenses **CANNOT** be reclaimed.

Any issues/queries relating to expenses and election literature should be directed to the Electoral Commission as they are not matters for the Returning Officer

General Information

All election literature which candidates produce must contain an imprint. The printer, the promoter and any person on behalf of whom the material is being published (and who is not the promoter) must be included. If this is missing, as stated above this is not a matter for the Returning Officer and any queries or complaints must be directed to the Electoral Commission.

Election Agents –District candidates may appoint an election agent (forms for appointments are in the nomination packs). If a candidate does not appoint an agent then they are deemed to be their own agent. There is no provision for Parish candidates to have election agents.

Candidates can also appoint Opening of Postal Votes Agents and Counting agents. The number each candidate can appoint depends on how many candidates are validly nominated and therefore the totals will be issued following close of nominations.

As part of your campaign you may encourage electors to vote by post or proxy if they cannot vote in person on the day. It is advisable to ask the elector to contact us direct for the form.

An elector can only act as a proxy for 2 other people unless they are a close relative.
